

## Announcement/ Invitation to the Candidates

“The Hellenic Telecommunication & Post Commission (EETT) seeks to award contract, by the procedure of “direct award” on the basis of a short market research, as stipulated in article 8§3 of the “Regulation regarding EETT’s Contract Award”<sup>1</sup> for Supplies, Services and Design Contests” in order to obtain consulting services concerning market analysis and assessment of Significant Market Power (SMP) in the context of European Commission Recommendation on relevant product and service markets within the electronic communication sector susceptible to ex ante regulation in accordance with Directive 2002/21/EC of the European Parliament and of the Council on a common regulatory framework for electronic communication networks and services<sup>2</sup>, specifically for the following markets:

- (i) Wholesale (physical) network infrastructure access (including shared or fully unbundled access) at a fixed location (market 4 of Commission Recommendation)
- (ii) Wholesale broadband access (market 5 of Commission Recommendation)
- (iii) Voice call termination on individual mobile networks (market 7 of Commission Recommendation)

The estimated total value of the contract shall not exceed 149.000,00 € plus VAT.

Services shall be provided in the Contractor’s premises. The contractor shall meet with EETT periodically in EETT’s premises.

EETT will sent the detailed Notice, inviting them to submit their tender to EETT only to candidates selected based on the criterion of special expertise in projects relevant to market analysis and assessment of Significant Market Power (SMP) in at least one (1) of the aforementioned electronic communication markets in the context of either the current or the former Commission Recommendation<sup>3</sup>.

1. Letter of interest
2. List of the projects carried out related to market analysis and assessment of Significant Market Power (SMP) in at least one (1) of the aforementioned electronic communication markets (markets 4, 5 and 7 of the Commission Recommendation), in which the candidate Contractor was the main Contractor.
3. Evidence of the as above required experience, in particular certificates of satisfactory execution, issued by the recipient, for the most important projects of the aforementioned, or, failing this, simply a declaration by the candidate Contractor.

EETT shall prefer as candidate Contractors the ones which shall demonstrate special experience in all three aforementioned markets.

The contract award criterion shall be the tender with “the lowest price”, without prejudice to the provisions of article 8 paragraph 3,c of the current “Regulation regarding EETT’s Contract Award”<sup>4</sup> for Supplies, Services and Design Contests”
