EXECUTIVE SUMMARY

This is a summary of the Bidding terms & procedures in English language. In case of differences between this text and the Greek original, the Greek original shall prevail.

0.1. Rights of Use and Granting Process

The procedure described in the draft Tender Document (full version is available in Greek on the EETT website) will result in the administration of:

- One national right of use consisted of four (4) channels of 8 MHz in the radio frequency band of 470 790 MHz
- Thirteen regional rights of use consisted of one (1) to three (3) channels of 8 MHz in the radio frequency band of 470 790 MHz

More specifically, the radiofrequency blocks depicted in the following two tables will be granted:




Figure 1. Allotments according to the 42800/2012 ministerial decision

0.1.1. Duration of Rights of Use

The duration of rights of use is 15 years.

0.1.2. Reserve Price for Spectrum Rights of Use

The proposed Reserve Price represents the minimum valid Bid of the auction per each Spectrum Right of Use. The reserve price is presented in the following tables:

0.1.3. Licensees' Rights

The assignment of spectrum rights of use in the above bands grants the right of installation, operation and exploitation of a digital terrestrial broadcasting network, so as to provide a digital terrestrial broadcasting services in the Greek territory.

Successful bidders will be granted the right to install multiplexing and transmission systems, capable of providing digital terrestrial broadcasting services to the public.

Successful bidders have to implement at least the network described in the ministerial decision 42800/2012 (DVB frequency map) in order to fulfill a 95% population coverage.

0.1.4. Pre-qualification

The main pre-qualification criteria of the Participants in the Auction are:

(a) Submission of a complete Application.

The Application must comply with all the conditions presented in Chapter 5 of Tender Document. Failure to submit all necessary documents within the predetermined time period may result in the disqualification of the Applicant from the Auction.

(b) Certification of the adequacy of financial resources.

EETT will evaluate the adequacy of the candidate's financial resources, required for the minimum development of the network and the provision of services, on the basis of a minimum amount of shares, or equity or net book value of fixed assets equal to three million Euro (3,000,000 Euro) for the national spectrum right and equal to one hundred thousand Euro (100,000 Euro) for the Regional Spectrum Rights.

- (c) Proven ability both technical and managerial to cope with the strict timeframe for the switch from analogue to digital TV networks and inform the public.
- (d) Submission of a Participation letter of Guarantee.

0.1.5. Rules of the auction

The design of the Auction is based on Multiple Rounds Ascending with Simultaneous Separate Bids for Spectrum Rights.

All Bidders, to the extent that they are not Current Price Bidders, they may:

- Submit a Bid for Spectrum Rights for which they are not the Current Price Bidder.
- ii. **Waive:** A Bidder may exercise a waiver right as an alternative to making a Bid. Each Bidder may exercise up to six (6) waiver rights during the Auction,.
- iii. **Withdraw from the Auction:** A Bidder who is not a Current Price Bidder may formally withdraw from the Auction.

The Current Price Bidder, is not allowed to withdraw the bid which nominates him as the highest Bidder.

In case there is no successful bidder for any regional spectrum right(s), the successful bidder for the national spectrum right will be obliged to purchase the regional spectrum rights at reserve price.

In case there is no successful bidder for the national spectrum rights, a new tender document will be published for four individual single-MUX spectrum rights.

The Auction will run electronically via a special software, at EETT's premises, in Athens Greece

0.1.6. Payment Terms

The Final Auction Bid is paid as follows:

- Either 100% of the Final Auction Bid to be deposited in a bank account specified by EETT, within ninety (90) days following EETT's Decision announcing the successful bidders or
- 50% of the Final Auction Bid to be deposited in a bank account specified by EETT, within ninety (90) days following EETT's Decision announcing the successful bidders. The remaining 50% of the Auction Bid has to be paid in five (5) equal annual installments, adjusted by the twelve month Greek government treasury bill interest rate and increased by an additional 0.25 percentage basis points (0.25%). The first annual installment date is set on March 1st, 2017,or
- In case the successful bidder for the spectrum rights mandatory undertakes at least one of the regional spectrum rights, 30% of the Final Auction Bid has to be deposited in a bank account specified by EETT, within ninety (90) days following EETT's Decision announcing the successful bidders. The remaining 70% of the Auction Bid has to be paid in seven (7) equal annual installments, adjusted by the twelve month Greek government treasury bill interest rate and increased by an additional 0.25 percentage basis points (0.25%). The first annual installment date is set on March 1st, 2017.
